**Schedule of Dues:** GADA dues are based on previous year's new car and truck retail sales. If you are a new dealership, dues are based on anticipated sales for the next 12-month period. GADA dues year begins on July 1 and runs through the next June. As a new member, your dues are determined by the month that you join as well as sales volume. If you join GADA in May, June, or July, your dues will be the annual amount. If you join any other month your dues are prorated for the balance of the months remaining through the next June, including the month you join. (Please check appropriate section below)

After the first year, you will be billed for the annual amount in advance during the month of June. According to IRS rules, GADA dues are partially deductible as an ordinary business expense. Each year you will be notified of the percentage that is deductible.
